Candidates are evaluated on 1) service to enhance the prestige of rural electric cooperatives; 2) leadership in local communities and other cooperative organizations; 3) exceptional leadership and contributions to NDAREC and the rural electric program; and 4) unusual devotion to duty.

Eligible nominees include rural electric directors of active or retired status.

- Describe nominee's specific service and contributions to NDAREC.
- List nominee's involvement and contributions to NRECA and other cooperative organizations.
- Identify accomplishments and contributions to the electric utility industry.
- Not to exceed three single-spaced, typewritten pages for all of Section 2.
